

DOCUMENTATION

Please find attached 3 documents that require completing and examples of how to complete these.

- **Packing Declaration**
This should be completed / signed off by the person who has prepared / packed the shipment and can effectively be signed once the shipping stillage is finalised at Donnington.
- **Freight Manifest Summary**
Please categorise your equipment in the following categories:
 - Bike (Year / Model / Make / VIN No / Engine No)
 - Tyre
 - Tools / Toolbox
 - Protective Clothing
 - Fairings / Bodywork
- **Invoice Summary**
 - The values declared should be standardised and kept as low as possible. The values are for UK & Australian customs rather than a commercial transaction.

Additional guidelines for packing of your stillage:

- No Wooden items to be shipped
- No Food to be shipped
- Second Hand / Used tyres are banned unless these are fitted to a Motorbike and if this is the case they must be spotless / as new as possible.
- Customs will check a random amount of bikes and they will be looking for VIN Numbers against paperwork – it will be helpful if these are accessible / visible and even some tape highlighting the area all go a long way to help and will avoid any stillages being completely unpacked.
- Fuel tanks should be drained as much as possible (no more than ¼ full)
- Cotton blankets recommended and clear wrapping (leaving the top free for circulation)
- Batteries should be disconnected
